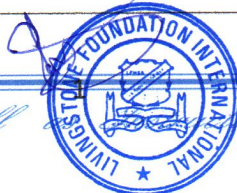
LFI will have a 15-member School Management Committee. The Constitution of SMC as on 1st April 2023 is as given below:.

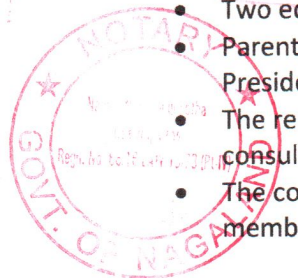

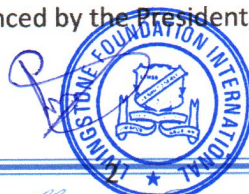

Guidelines for Constitution of SMC:

- The Chairman, 03 other Trustees & Head Master will be Ex-Officio members of the SMC.
- Two educationists may be nominated by the Trust or CBSE.
- Parents of a male-child and female-child studying in LFI will be nominated as members of SMC by the President, in consultation with Principal.
- The remaining members of SMC, including professional experts will be nominated by the President, in consultation with Principal.
- The composition of SMC can be enhanced by the President, Trust subject to a maximum of 21 members.
